Physical Classroom COVID Policy Updates:

We will have face-to-face instructional sessions to accomplish the student learning objectives of this course. In response to COVID-19, the following policies and requirements are in place to maintain your learning environment and to enhance the safety of our in-classroom interactions.

Zoom Classroom COVID Policy Update:

Our class sessions may be audio visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. Likewise, students who un-mute during class and participate orally are agreeing to have their voices recorded. If you are not willing to consent to have your voice recorded during class, you will need to keep your mute button activated and communicate exclusively using the "chat" feature, which allows students to type questions and comments live. The chat will not be recorded or shared. As in all courses, unauthorized recording and unauthorized sharing of recorded materials is prohibited.

COVID Safety Essentials:

On face to face instruction days, faculty and students must adhere to the following practices:

- Physical Distancing: Whenever possible, maintain a physical distance of 6 feet from others while on the University of Florida properties and in common spaces until further notice.
- Face Coverings: Face coverings are required inside all campus buildings.
- Wash Hands Frequently: Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing or sneezing. This seminar course for students selected for the College of Agricultural and Life Sciences Leadership Institute includes an International Service & Learning Experience as a context for application of course content previously covered in the program. A compilation of documentation supporting leadership growth and reflection serves as closure to the course.

COURSE POLICIES
