Course Tasks

Pre-Trip Participation

Throughout the first half of the semester, we will meet as a group to discuss Costa Rica, aspects of the trip, and course subjects. Readings, in-class activities, and outside exercises will be assigned. We will attempt to find times when you can all participate in class meetings but be aware that there are many students in the class, and we likely won't get all of you at any one time. If you do miss a meeting, then you'll need to work with Drs. Stein or Andreu to get the information presented at that meeting and complete assigned work.

"Things to Know" Review

The undergraduate students will be writing 2-3-page papers regarding various aspects of Costa Rica. You will not be required to write a paper. However, you will be reading these papers, grading them for quality (we will allow students to improve papers based on your comments for improved grades). You will submit electronically marked copies with your comments to Dr. Stein by the deadline.

"Things to Know" Questions

After reading the "Things to Know" papers, you will develop ten multiple choice or fill in the blank questions based on those readings (avoid true and false and questions that require more than one or two word answers). These questions will be incorporated into worksheets that the undergraduates will complete to ensure they read all the "Things to Know" papers. Do your best to write challenging questions, but make sure they are answerable (i.e., 1 correct answer and 3 incorrect answers).

Submit your questions in an MS Word file. You will write three to four questions for each paper assigned to you (ensuring you write a total of ten questions). In your document write the name of the paper and author for each paper assigned to you, and then list the questions below the name of each paper.

Trip Journal (Due: Every day of the trip)

All students will write a summary of what you learned each day of the trip. This can be both personal observations, as well as, information you will need to write your Course Paper (see below). You should take notes while visiting the locations, listening to guides, and observing situations throughout the trip. You will then use that information in your final paper. Although we will check your journal every night (or morning) to ensure you are writing, we will not be looking for you to write about specific information. This is your opportunity to record information you think is important.

Ecotourism Exercise

Ecotourism is a major part of Costa Rica's economy, use of natural resources, and your current experience on this study abroad program; therefore, it's beneficial that you have a basic understanding of the concept. To gain this understanding, you will review two articles related to ecotourism and answer a series of questions related to ecotourism and the articles while on the trip. You will be able to answer the questions through written text, taking pictures, drawing diagrams, or any other creative way you find to answer the questions. The questions will come from the readings and will ask you to identify or describe elements from the trip that relates to those readings that you observed or learned about while traveling.

Worksheets (Due: Depends on worksheet)

Prior to and during the trip you will receive worksheets that you will need to complete using information you receive on the trip. Some of these questions will require you to provide factual information (in other words, there is a *correct* answer), and other questions require you to provide an *informed* opinion. Other questions will be a mix of both types. Responses will be graded based on the quality (not length) of the response. Although you can share information among each other, YOU MUST answer the questions in your own words. Copying is not accepted and will result in a 0 for that worksheet.

Course Paper

You will write a paper that answers a question about something you learned while on the trip. You will be free to choose any topic of interest to you, as long as it directly relates to tropical ecosystems or Costa Rica in some way. You should have a topic chosen by March 3, but you can adjust your topic during the trip if needed. If you want to change the topic, discuss your change with Drs. Stein or Andreu or Andres Leon. Unlike the undergraduate students, you will be free to use literature when writing your paper. However, I must see some direct connection between information you learned on the trip and your final paper. The paper should be between 12 and 18 pages, double spaced.

Participation

You are expected to actively participate in all aspects of this trip. Since this course does not rely on exams and lectures, it is dependent upon you to take part in organized activities and do your best to contribute to assignments, presentations, and discussions.

We will meet several times before we travel to Costa Rica. These meetings will serve to educate all students about the country, but we will also provide important information about the trip. Please do your best to attend these meetings. If you cannot attend, please let me know and arrange another time to meet.

The quality of this trip depends on the behavior of the participants. *This is a study abroad tour – not a spring break vacation*. We often have to get up early, follow tight schedules, and visit areas where you must act courteous and professional. Participating in any disruptive behavior or failing to follow the schedule impacts, the entire group and your ability to benefit from the tour. Actively listening to tour guides and experiencing the diverse places we visit are imperative to enjoying and getting a good grade in this course. Although you will have free time, these requirements still apply during your free time, and you are required to stay with the group and act appropriately. Please carefully read all agreements and waivers you have signed to participate in this class.
